

# **VSS Catholic Communications, Inc dba - Spirit Catholic Radio Network Listen2Win Holy Land Pilgrimage Drawing Official Rules**

## **1.1 Purpose:**

VSS Catholic Communications, Inc. dba Spirit Catholic Radio Network (Spirit Catholic Radio) is honored to present a once-in-a-lifetime opportunity to travel to the Holy Land with the staff of Spirit Catholic Radio and Steve Ray (“Pilgrimage”).

## **1.2 Eligibility**

This drawing is open to all those who have pre-qualified as a result of registering to play Listen2Win (are 18 years of age or older at the time of registering) and heard their name called and then responded within 10 minutes and 27 seconds. Employees of Spirit Catholic Radio or the immediate family members of Spirit Catholic Radio employees are prohibited from entry. All federal, state, municipal and local laws and regulations apply. Void where prohibited by law. Odds of winning are determined by the number of pre-qualified registrants. This drawing may be discontinued at any time without notice. ## **1.3 How to Enter**

Other opportunities to register are as follows – text Listen2Win to 55222, attend a Spirit Catholic event and receive a specific text code. One entry per person per household per or mailing address unless they attend an event where an additional code is given for attending the event. In the case of multiple entries by the same person, all entries may be discarded, and the entrant disqualified. Spirit Catholic Radio reserves the right to disqualify any entrant or winner (whether or not the winner’s identity has been announced) who does not adhere to the rules applicable to the drawing in which he or she entered or who gains an unfair advantage through fraud or unsportsmanlike conduct in participating in the contest. Drawing runs from April 1 to June 30, 2019. Entry deadline is June 28th, 2019 before 4:00pm.

## **1.4 Pilgrimage Information**

The Pilgrimage dates are November 13th-22nd, 2019. Pilgrimage drawing package is for two people and based upon double occupancy. Winner must provide their own transportation to Omaha, NE (point of departure) at their cost. Cost and fees are not included and are the sole responsibility of the winner, including but not limited to: Anything not listed as being covered. Winner must claim prize by returning to Spirit Catholic Radio at 13326 A Street, Omaha, NE 68144 completed IRS Forms and registration form. Winner must have a valid passport and is responsible for obtaining one at least 60 days prior to departure. The expiration date of the passport cannot be past May 1, 2020.

## **1.5 Winner Selection**

Winner will be drawn on July 1, 2019 and announced on-air by Spirit Catholic Radio. Within six (6) days of notification by phone, the winner must complete and return the registration forms and IRS Forms to Spirit Catholic Radio. Failure to timely and properly claim the Pilgrimage will result in forfeiture and another winner will be selected.

Prize has no cash value, expressed or implied. All pilgrimages are non-transferable. No substitution will be made. Spirit Catholic Radio reserves the right to substitute another pilgrimage of equal or lesser value for the prize originally announced if the original drawing prize is or becomes unavailable.
